POWER TO YOU(TH): A TRANSFORMATIVE JOURNEY TOWARDS INCLUSIVE EMPOWERMENT.

The Power to You(th) programme is a five-year, multicountry consortium (2021–2025) led by Amref Health Africa in collaboration with Sonke Gender Justice, Rutgers, and CHOICE for Youth and Sexuality, with funding from the Dutch Ministry of Foreign Affairs. Over the past five years, the programme has empowered adolescent girls and young women from underserved communities in Kenya, Uganda, Malawi, Ethiopia, Ghana, Senegal, and Indonesia to take an active and meaningful role in decision making about their bodies and their Sexual and Reproductive Health and Rights. We have also worked to challenge and transform harmful cultural norms including child marriage, Female Genital Mutilation, Sexual and Gender Based Violence and unintended pregnancies.

Through youth-led, gender-transformative approaches, we have directly empowered more than 36,000 young people to challenge harmful norms, take leadership roles, and engage in community dialogues, reaching more than 200,000 people through campaigns, advocacy & awareness creation, and more than 5 million people through media platforms.

Power to You(th) has not only contributed to shifting existing power dynamics, it has also ensured that youth are not only heard but also actively shape policies and decisions that affect their lives. In doing so, Power to You(th) stands as a catalyst for lasting systemic change in youth inclusion and gender justice.



The Power to You(th) experience was life-changing to me. It not only strengthened me but also opened the door to more training and knowledge on early marriage, Female Genital Mutilation/Cutting and Sexual and Gender Based Violence. Now, I'm equipped to educate my friends, family and the community, working to eliminate these from our society. I empower other girls by teaching them what to do and how to report when they face such situations.

Since its inception, the Power to You(th) programme has impacted more than **36,000 young people** across Kenya, Uganda, Ghana, Indonesia, Ethiopia, Malawi and Senegal through capacity strengthening, empowerment programmes and supporting youth-led social accountability and advocacy. These interventions have gone beyond raising awareness; they have empowered young people to question restrictive norms, step into leadership roles within their communities, and actively participate in, as well as meaningfully influence, key decision-making platforms.

This strengthened their understanding of governance systems and enhanced youth participation in communitylevel planning and decision-making spaces, including youth parliaments, safe spaces, and accountability forums.

As a result, the space for dialogue between youth and key government decision-makers has expanded, allowing young voices to shape policies and influence resource allocation. This shift has transformed youth from passive recipients of policy decisions into active leaders driving change and advocating for policies that protect their collective future.

The recently concluded End Term Evaluation highlighted that, "PtY contributed to multidimensional impact at individual, community, and institutional levels. Youth reported enhanced agency, leadership, and civic engagement, while community dialogues and media campaigns catalyzed shifts in gender norms and reduced tolerance of harmful practices. At the institutional level, PtY contributed to policy reforms, SRHR budget allocations, and youth inclusion in governance structures" (End Term Evaluation PtY 2025)



COUNTRY SPOTLIGHT: SOCIAL NORM CHANGE!





Ethiopia

In Afar, one of the implementation regions, religious leaders joined hands with young people to help stop over 50 child marriages.



Malawi

In Machinga region, intergenerational dialogues resulted in the 'chief forum' enacting a by-law against underaged marriage and returning 91 married girls to school.



Uganda

35 faith and cultural leaders in Kampala co-authored an inter-faith commitment to end teenage pregnancy and child marriage codifying messages and concrete roles for their institutions.



Kenya

Intergenerational dialogues in 4 counties broke taboos around sexuality, menstruation and early marriage, creating solidarity between youth and elders.



Through the 'Grandmother Project approach' the programme was able to break taboos and change social norms on FGM.



Indonesi

PtY supported the scale-up of Reproductive Health and Sexuality Education to 643 schools which changed knowledge and attitudes on SRHR.



Beyond grassroots impact, we have strategically worked to influence institutional change, contributing to significant policy shifts or reforms. These included changes in over 70 laws and policies related to the age of consent, child marriage, FGM, Sexual and Gender Based Violence and Comprehensive Sexuality Education many of which were catalyzed by coordinated campaigns and policy dialogues led by youth networks supported through Power to You(th).





Ghana

Advocacy by Power to You(th) partners under the "don't tax my period" campaign contributed to removal of taxes on sanitary pads.



Uganda

PtY youth coalitions in Mbale and Busia achieved increased Family Planning budget allocations and SRHR inclusion in district development plans.



Ethiopia

PtY advocacy led to adoption of the 'Family Law' in Afar Region, a landmark reform addressing child marriage, FGM, and inheritance rights.



Malaw

Power to You(th) partners contributed to revision of the National Gender Policy, which now specifically includes youth SRHR and harmful practices prevention.



Senegal

Advocacy led to increased budgetary allocations to youth-friendly services integrated into local government budgets in Mbacké, Thiès, Fatick, Rufisque, Guédiawaye, and Matam.



Kenya

Youth Parliament advocacy sparked national conversations on crossborder Female Genital Mutilation practices. More than 500 youth were engaged in legislative dialogue spanning the Kenya–Tanzania border.



Indonesia

PtY Indonesia worked with district and village governments in Garut and East Lombok to translate the national child marriage prevention strategy into local plans and regulations. Awareness raising, advocacy and improved enforcement has led to a decrease of 15% in child marriage cases in Garut and East Lombok between 2021 - 2024.

At the global and regional level, Power to You(th) expanded its advocacy efforts through various activities, including digital campaigns and engagement in key international policy spaces, such as the Commission on the Status of Women, the Human Rights Council, the Commission on Population and Development, and the Summit of the Future. Sonke and AMREF, alongside partners in Uganda, successfully advocated for the introduction of a comprehensive Elimination of Female Genital Mutilation (FGM) Bill, which was tabled at the East African Legislative Assembly (EALA) and subsequently gazetted.



LEARNING, COLLABORATION, AND ADAPTIVE PRACTICE

Power to You(th) fostered a strong culture of research and learning, recognizing that lasting transformation must be grounded in evidence. In a world where harmful practices, SGBV, and unintended pregnancies remain deeply rooted, the programme has co-created

data-driven solutions alongside young people. Through operational research, surveys, country exchanges, human-centered design pilots, and external evaluations, Power to You(th) has continuously learned, adapted, and refined its approaches to enhance effectiveness.





When young people are given space, listened to, and assisted, we can show tremendous potential. We are not just beneficiaries — we are the main actors of change.
